### **Pandora Event Guidelines**

1) All Pandora events must have an initial give away of 1 bracelet and 1 charm as a gift.

**2)** Event is then allowed to offer another 4 additional charms as a type of play to win. This makes a total charm offering of a selection of 5 charms for the event.

2a) Add 1 silver and or 1 glass custom engraved charm to the guest assortment. Total for offering selection is now 6 to 7 charms total adding custom charm options.

**3)** Only exception for a 6th charm is including the Dangle Custom charm at an MSRP of \$55. Or smooth Murano glass charm option Min 50 pc.

4) 10% returns accepted per SKU. Additional returns are subject to a 15% restocking fee.

5) NO RETURNS allowed for the Custom charm.

6) All clients must fill out a Pandora Event Request form, including details of the event, skus included etc.

7) All marketing material must be created by Pandora. There is no charge to the client for the creative work. Approved PDF high resolution marketing will be supplied to the client for print or electronic use. Pandora marketing department will work with you or directly with the client's marketing/art departments to coordinate the efforts for fantastic results.

8) Lead time for all events is 60 to 90 days.

- Engraving on Approved Charms only
- Signed Letter of Authorization to utilize logo prior to digital mock up process
- Obtained signed Terms and Conditions form from client.
- Submit designs concepts
- Will be sent to the graphics team and digital mock-up will be re turned for their review within 48 hours.
- If approved, supply PPR with signed PROOF /AUTHORIZA TION FOR PHYSICAL SAMPLE form.
- Expect physical sample to be shipped within 5 7 Business days.
- If not approved, submit signed PROOF /AUTHORIZATION Form with appropriate changes.
- MOQ : 50 pcs per design
- Pricing : Adhere to Premium Pandora Engraving Policy Pricing
- Lead time: 21 Business Days. More than three colors in artwork may affect the lead time.
